Terms of Use

这些使用条款（统称为“条款”）规定了具有法律约束力的条款和条件，适用于您对任何应用程序（“应用程序”）的使用。在此政策中，该应用程序也可能指“我们”。

These Terms of Use (collectively the «Terms») set forth the legally binding terms and conditions which are applicable to your use of any of the Applications («App» or «Apps»). In this policy, the app may also refer to «We» or «Us».

1. Agreement

1.1 License

1.1 许可证

根据本协议的条款,我们授予您不可转让,非专有的许可,以(a)供您个人使用,以及(b)复制(用于下载,安装和执行),您拥有或控制使用的移动设备上的每个应用程序的下载网站(“许可”)授权您对此进行授权。

Subject to the terms of this Agreement, we grants you a non-transferable,nonexclusive, license to (a) use for your personal use, and (b) copy, forthe purpose of downloading, installing and executing, the number of copies for which you are authorized by the download site of each App on a mobile device that you own or control for your use (the «License»).

1.2 某些限制

1.2 Certain Restrictions

unless otherwise provided in terms associated with such addition. All copyright and other proprietary notices on any App content must be retained on any copies.

1.3 当地法律

1.3 Local Laws

The app (and its licensors, where applicable) reserve all rights not granted in this Agreement.

2.1 用户内容

2.1User Content

2.4 Acceptable Use Policy

The following sets forth our app 's «Acceptable Use Policy»:

(1) You agree not to use any App to upload, distribute, or otherwise use any User Content (a) that violates any third-party right, including any copyright, trademark, patent, trade secret, moral right, privacy right, right of publicity, or any other intellectual property or proprietary right; (b) that is tortious, trade libelous, defamatory, false, or intentionally misleading, (c) that is harassing, abusive, threatening, harmful, vulgar, obscene, offensive or that contains pornography,

3.期限和终止

3.Term and Termination

Even after this Agreement is terminated, the following provisions of this Agreement will remain in effect: Sections 1.2, 1.3, 1.4, 1.5, 2, 3.4, 4, 5, 6, 7, 8 and 9.

4. Indemnity

5.1 应用程序商店。
